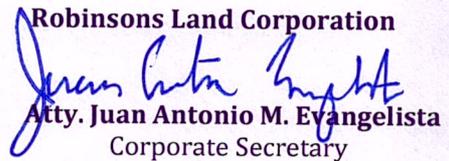
Please be informed that the Board of Directors of RLC approved the following organizational changes at its meeting held on January 6, 2025:

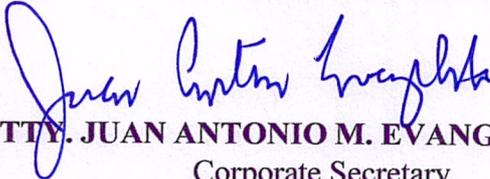
