("PhilWind") for the additional subscription by ACEN to 50,446 Redeemable Preferred Shares A-3 ("RPS A-3") at par value of Php10,000.00 per RPS A-3 of PhilWind, for a total subscription price of Php504,460,000.00 (the "Subscription Price"), to be issued out of the increase of PhilWind's authorized capital stock (ACS).

PhilWind is a majority shareholder of North Luzon Renewables Energy Corp. ("NLR"). NLR wholly owns Amihan Renewables Energy Corp., which owns the 70MW wind farm in Pagudpud, Ilocos Norte.
