In relation to our disclosure last April 15, 2025, please be informed that Republic Act No. 12146 (R.A. 12146) was signed into law on April 11, 2025 as published in the Official Gazette website of Malacañang.

R.A. 12146 renews the franchise granted to Manila Electric Company for another twenty-five (25) years, authorizing the Company to construct, operate, and maintain a distribution system for the conveyance of electric power to the end-users in the cities/municipalities of Metro Manila, Bulacan, Cavite and Rizal, and certain cities/municipalities/barangays in Batangas, Laguna, Quezon, and Pampanga.

The new twenty-five (25) year franchise period will commence upon the expiration of the current franchise granted under Republic Act No. 9209, which expires on June 28, 2028.

R.A. 12146 will take effect fifteen (15) days from the date of its publication, in at least two (2) newspapers of general circulation in the Philippines.
