ITEM 9. OTHER EVENTS

We advise that-

1. At the annual stockholders' meeting of the Company, the stockholders approved the appointment of SGV & Co. as the Company's external auditor for 2025-2026.
2. During the Board's organizational meeting, the Board approved the declaration of regular cash dividends, out of the unrestricted retained earnings of the Company, of approximately Php3.03 Billion to stockholders of record as of May 31, 2025, payable on or before June 30, 2025, as follows:
 - (i) regular cash dividends of approximately Php146,816.35 per share or a total of Php2.5 Billion in favor of holders of common shares;
 - (ii) regular cash dividends of approximately Php47,957.33 per share or a total of Php449.6 Million in favor of holders of voting preferred shares; and
 - (iii) regular cash dividends of approximately Php1.97 per share or a total of Php82.8 Million in favor of holders of non-voting preferred shares.
