Amendment of Facility Agreement

Background/Description of the Disclosure

To recall, on 22 December 2023, ACEN, as the lender, signed a Facility Agreement (the "Agreement") for ACEN to provide a credit facility in the aggregate amount of up to Php200,000,000.00 in favor of YMP Telecom Power Inc, as the borrower, for the purpose of funding development costs of certain energy efficiency and renewable energy projects of YMP Telecom Power Inc., which is a subsidiary of Belenos Energy Corporation, a wholly owned subsidiary of ACEN.

Please be informed that, at the request of YMP Telecom Power Inc., ACEN signed today, 22 May 2024, a request letter agreeing to amend the terms of the Agreement to increase the total facility amount from Php200,000,000.00 to Php466,000,000.00.
