ITEM 9. OTHER EVENTS

We advise that on June 10, 2024, the Company received from the Department of Labor and Employment Regional Office No. IV-A (CALABARZON) a Writ of Execution dated June 4, 2024 (“Writ”), in relation to its alleged Order dated January 27, 2023 directing the Company to submit certain documents pertaining to Occupational Safety and Health Standards. For the Company’s alleged failure to submit the required documents, the penalty amounting to Fifty Thousand Pesos (Php50,000.00) was imposed, in addition to execution fees and legal expenses incurred in the enforcement of the Writ in the amount of Eight Hundred Pesos (Php800.00). The Company will take action as appropriate in response to the Writ, considering all available legal remedies.




