## **MPTC acquires 2.61% government shares in NLEX Corp.**

Pangilinan-led Metro Pacific Tollways Corporation (MPTC) has recently acquired the 2.61-percent government stake in NLEX Corp to support the government's effort to fortify its monetary chest.

MPTC President and CEO Rogelio Singson reaffirmed the tollroad company's dedication to supporting the government's efforts and its commitment to public service. "We recognize that we, too, are in public service under a private entity. Our commitment is to provide efficient, safe, and convenient travel to our motoring public, as well as connect people and transform communities," said Singson.

The deal was finalized in a ceremonial signing last August 2 with officials from the tollroad giant led by Singson and MPTC Chief Finance Officer Christopher Lizo, with the Department of Finance Secretary Ralph Recto and Privatization Management Office Chief Atty. Maan Doctor.
