Please find attached the amended **2024** General Information Sheet (GIS) of **Arthaland Corporation (the "Corporation")** which amends the one filed on 07 August 2024. Page 3 of this GIS now reflects the following pursuant to the disclosure made *via* SEC Form 17C filed of even date:

1. The Corporation's authorized capital stock is Philippine Pesos: Three Billion Twenty Six Million Two Hundred Fifty Seven Thousand One Hundred Thirty Five and 82/100 (₱3,026,257,135.82) divided into Philippine Pesos: Two Billion Nine Hundred Forty Six Million Two Hundred Fifty Seven Thousand One Hundred Thirty Five and 82/100 (₱2,946,257,135.82) of common shares consisting of 16,368,095,199 common shares with a par value of Philippine Pesos: Eighteen Centavos (₱0.18) per share and Philippine Pesos: Eighty Million (₱80,000,000.00) of preferred shares consisting of 80,000,000 preferred shares with a par value of Philippine Peso: One (₱1.00) per share; and
2. The Series E Preferred Shares of the Corporation is now 14,000,000.

Further, page 8 of the GIS reduced the number of treasury shares to just 10.0M and additional 12.5M preferred shares was issued representing Series E Preferred Shares.
