Please be informed that Manila Electric Company (the "Meralco") has completed the acquisition of 28,053 common shares of CIS Bayad Center, Inc. ("CBCI") from Densan System Co., Ltd. ("Densan") today for a total consideration price of PhP241,500,000.00. Densan, a Japanese company that launched Japan's first convenience store payment service, invested in CBCI in 2017.

Following the acquisition by Meralco, the ownership structure of CBCI will be as follows: Customer Information Solutions, Inc. – 85%, Kayana Solutions, Inc. – 10%, and Meralco – 5%.

Customer Information Solutions, Inc. is a wholly owned subsidiary of Meralco.
