By way of update to the 24 October 2024 disclosure on the joint venture company, IBV ACEN Renewables Asia Pte. Ltd. (the "JV Company"), please be advised that on 11 December 2024, with all conditions having been satisfied under the Sale and Purchase Agreements, transaction closing was achieved for the JV Company's acquisition, through Sonagazi Sun Holdings Pte Ltd, of 49% interest in a c. 70MW Bangladesh solar project ("Sonagazi Power Project") at an acquisition price that is less than 10% of the book value of ACEN as of 30 September 2024.
