On 29 April 2022, AC then declared these 1,861,000,000 ACEN shares as property dividends to its shareholders as of 27 May 2022.

Out of the 114,443,381 ACEN common shares, 13,750,763 ACEN common shares have yet to be distributed to its stockholders as disclosed under AC's PSE EDGE Disclosure Report No. C00247-2023 dated 10 January 2023, while the 100,603,569 ACEN common shares are AC's own shares, representing the total amount of final withholding tax on the property dividends remitted by AC to BIR. AC issued a declaration of trust with respect to the undistributed ACEN common shares conveying beneficial ownership of said shares to the entitled stockholders.
