ACEIC retained beneficial ownership of the shares being the 100% subsidiary of AC. On 29 April 2022, AC then declared these 1,861,000,000 ACEN shares as property dividends to its shareholders as of 27 May 2022. As of 31 July 2022, AC has already distributed a total of 1,746,546,668 ACEN common shares to its qualified shareholders, pursuant to its property dividend payment process as disclosed under AC's PSE EDGE Disclosure Report No. C00247-2023 dated 10 January 2023.

Out of the said 114,354,332 ACEN common shares, 13,750,783 ACEN common shares have yet to be distributed to its stockholders as disclosed under AC's PSE EDGE Disclosure Report No. C00247-2023 dated 10 January 2023, while the 100,603,569 ACEN common shares are AC's own shares, representing the total amount of trust withholding tax on the property dividends remitted by AC to BIR. AC issued a declaration of trust with respect to the undistributed ACEN common shares conveying beneficial ownership of said shares to the entitled stockholders.
