

On 23 October 2025, the Board of Directors ("Board") of Megawide Construction Corporation (the "Company") has approved and authorized the declaration of cash dividends for the Company's Series 2B Preferred Shareholders at a dividend rate of PhP1.4375 per share, or a total of PhP25,020,953.00.
