The audited consolidated financial statements of the Company as at and for the year ended December 31, 2025 (the "2025 Audited Financial Statements"), and the submission to the SEC, the PSE, and the PDEX of the Annual Report of the Company (or SEC Form 17-A), including the 2025 Audited Financial Statements.
