Please be advised that, on 13 March 2026, Filinvest Land, Inc. (“FLI”, the “Company”, the “Issuer”) filed online via email its Registration Statement with the Securities and Exchange Commission (“SEC”) in connection with the offer and sale to the public of up to Nine Billion Pesos (Php9,000,000,000.00) worth of fixed-rate peso denominated retail bonds with an oversubscription option of up to Two Billion Five Hundred Sixty-Nine Million Two Hundred Thousand Pesos (Php2,569,200,000.00), consisting of up to three (3) subseries, namely: (a) 3.5-year Bonds due 2029; (b) 5-year Bonds due 2031; and (c) 10-year Bonds due 2036.

This latest bond issuance will be the third tranche out of its Php35.0 Billion Shelf-Registered Philippine Peso-Denominated Fixed Rate Bonds of the Company approved by the Securities and Exchange Commission under SEC MSR Order No. 64, Series of 2023.
