
Atty. Celeste B. Atas is the current Information Security and Data Privacy Legal Controls Head under the Data Privacy and Protection Office. She possesses the necessary expertise in integrating data privacy and information security controls, particularly in the review of third-party engagements and ensuring the protection of personal data. She holds relevant professional certifications, including National Privacy Commission DPO ACE Certification, IAPP Certified Information Privacy Professional/Europe (CIPP/E), ISC² Certified in Cybersecurity (CC), and Microsoft Certified: Azure AI Fundamentals (AI-900).

Upon joining the Bank, she handled litigation and dispute-related matters, including court proceedings, rehabilitation proceedings, criminal matters, regulatory exposures, and legal risk management, with regular engagement with regulatory and other government bodies. She also worked closely with the Bank's information security and data privacy functions, supporting initiatives with cross-functional impact, prior to transitioning to her current role.

Prior to joining the Bank, she served as Associate Counsel at Esguerra and Blanco Law Offices, where she handled litigation and advisory work involving commercial, civil, criminal, and regulatory matters, including representation in high-profile proceedings before various courts, regulatory bodies, and legislative bodies. Her experience also includes intellectual property matters, such as trademark prosecution, maintenance, and compliance filings.

Atty. Atas graduated with a degree in Bachelor of Arts in Communication Research from the University of the Philippines Diliman and obtained her Juris Doctor degree from the University of the Philippines College of Law.
