Subject of the Disclosure

CIAC Renders Decision in CIAC Case 02-2023 between Megawide Construction Corporation and ACI Inc

Background/Description of the Disclosure

On 11 January 2024, Megawide Construction Corporation (the "Company") received a decision dated 11 January 2024 rendered by the Construction Industry Arbitration Commission ("CIAC") Arbitral Tribunal for CIAC Case 02-2023 under which Respondent ACI Inc. was ordered to pay the Company the total amount of ONE HUNDRED EIGHTY MILLION TWO HUNDRED FORTY FOUR THOUSAND FORTY THREE PESOS AND FIFTY CENTAVOS (PhP180,244,043.50) with six percent (6%) interest per annum from the date of this Final Award until fully paid.

On 8 April 2025, the Company received a decision dated 22 January 2025 rendered by the Supreme Court First Division for G.R. No. 271315, ACI, Inc. ("Petitioner") v. Megawide Construction Corporation ("Respondent") which is a Petition for Review on Certiorari of the Final Award dated 11 January 2024 of the CIAC in CIAC Case No. 02-2023. The Court further resolved to deny the petition for failure of petitioner to sufficiently show that the CIAC committed any reversible error in the challenged final award. Further, the Court stated that the issues raised in the petition are substantially factual in nature.

On 12 May 2026, the Company received payment from ACI Inc. in the total amount of Two Hundred Five Million Seven Hundred Sixty-Five Thousand Five Hundred Eighty-Three Pesos and Seventy-Four Centavos (PhP205,765,583.74), representing the CIAC Final Award in favor of the Company and the corresponding accrued interest thereon.

Principal Parties

Megawide Construction Corporation and ACI Inc.

Nature and description of the legal proceedings

The Company filed a complaint against ACI Inc. with the CIAC last 10 January 2023 (the "Complaint"). The Complaint was docketed as CIAC Case 02-2023. The Complaint involved the contract entered into between ACI Inc. and the Company for the design and construction of the Araneta Cyberpark Tower 2. The Company's aggregate claim against ACI Inc. under the Complaint is Three Hundred Thirty-Nine Million Six Hundred Fifty-Two Thousand Eight Hundred Sixteen Pesos and Seventy-Three Centavos (PhP339,652,816.73).

In the decision rendered by the CIAC, which the Company received on 11 January 2024 (the "Decision"), the Company was awarded a total of Five Hundred Ninety-Six Million Eight Hundred Ninety Seven Thousand Nine Hundred Fifty Seven Pesos and Thirty One Centavos (PhP596,897,957.31).

Respondent ACI Inc., on the other hand, was awarded Four Hundred Sixteen Million Six Hundred Fifty Three Thousand Nine Hundred Thirteen Pesos and Eighty One Centavos. (PhP416,653,913.81).

In view of the foregoing awards, the net due amount to the Company is therefore One Hundred Eighty Million Two Hundred Forty Thousand Forty Three Pesos and Fifty Centavos (PhP180,244,043.50).

The CIAC ordered Respondent ACI Inc. to pay the Company the total amount of ONE HUNDRED EIGHTY MILLION TWO HUNDRED FORTY FOUR THOUSAND FORTY THREE PESOS AND FIFTY CENTAVOS (PhP180,244,043.50) with six percent (6%) interest per annum from the date of this Final Award until fully paid.

Petitioners ACI Inc. filed a Petition for Review on Certiorari of the Final Award dated 11 January 2024 of the CIAC in CIAC Case No. 02-2023 with the Supreme Court. The Supreme Court denied the petition and ruled in favor of the Respondents maintaining the final award of CIAC.

The Decision will not have a significant impact as far as the operations of the Company is concerned.
