ARTHALAND CORPORATION (the “**Corporation**”) was fined by the Securities and Exchange Commission (SEC) in the amount of ₱746,616.79 for violation of the Revised Securities Regulation Code Rule 68, having found errors in its cash flow reporting in the Consolidated Audited Financial Statements of the Corporation as of 31 December 2024. While the Corporation restated the 2024 Statement of Cash Flows in its 2025 Consolidated Audited Financial Statements to reflect the appropriate presentation, per the SEC, “the correction of such errors through restatement or re-issuance of the financial statements does not exonerate (it) from the penalty due to material misstatements in the original financial statements.”

Said fine was paid today and proof of payment is attached for your reference.

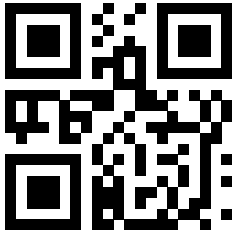
