Background/Description of the Disclosure

Please be informed that Renewable Earth Corp. ("Renovable") (as borrower, mortgagor, property security grantor and accounts security grantor), Yanara Philippines Corp. ("Yanara PH") (as sponsor and as shares security grantor), Rizal Commercial Banking Corporation (as the senior term lender), RCBC Capital Corporation (as mandated lead arranger), and RCBC Trust Corporation (as facility agent and security trustee), signed today an Omnibus Loan and Security Agreement for a senior secured term loan facility, in the amount of up to Php2,280,000,000.00, to partially finance Renovable's up to 75 MW solar power project in Sual, Pangasinan, Philippines.

Renovable is a subsidiary of Yanara PH, the joint venture corporation of the Company and Yanara APAC B.V.
